## COLLATERAL ASSIGNMENT OF TRADEMARKS

On this 31st day of August, 2016, CANADIAN IMPERIAL BANK OF COMMERCE, a Canadian chartered bank, with its mailing address at 199 Bay Street, 4th Floor, Toronto, Ontario M5L 1A2 Canada (the "Original Secured Party") collaterally conveys, assigns, transfers and sells all of its rights, benefits and obligations as the "Secured Party" in and to that certain Trademark Collateral Agreement referred to below and all of Original Secured Party's rights thereto to CANADIAN IMPERIAL BANK OF COMMERCE, a Canadian chartered bank ("CIBC"), with its mailing address at 199 Bay Street, 4th Floor, Toronto, Ontario M5L 1A2 Canada, acting as administrative agent (CIBC acting as such administrative agent and any successors or assigns to CIBC acting in such capacity being hereinafter referred to as the "New Secured Party") for certain Secured Creditors as defined in and pursuant to that certain Amended and Security Agreement dated as of even date herewith, by and among Gateway Services (USA), LLC, a Delaware limited liability company ("Debtor") with its principal place of business and mailing address at 170 Southgate Drive, Guelph, Ontario N1G 4P5 Canada ("Debtor"), certain affiliates of Debtor, as debtors, and CIBC, as administrative agent (the "A&R Security Agreement").

NOW, THEREFORE, for good and valuable consideration, receipt whereof is hereby acknowledged, the parties hereto agree that all trademarks, trademark registrations, and trademark applications and rights therein of Debtor in favor of the Original Secured Party, including without limitation, all such property set forth in that certain Trademark Collateral Agreement dated September 1, 2015 by and between the Debtor and the Original Secured Party recorded with the United States Patent and Trademark Office on September 2, 2015 in Reel 5615, at Frame 0391 (the "Trademark Agreement"), as listed on Schedule A attached hereto and made a part hereof are collaterally transferred and assigned, with their goodwill, to the New Secured Party. All liens and other security interests heretofore vested against those trademarks, trademark registrations, and trademark applications and rights thereto in favor of the Original Secured Party under the (i) Security Agreement (as such term is defined in the Trademark Agreement) which has been amended and restated in its entirety by the A&R Security Agreement, and (ii) Trademark Agreement, remain effective now as against property interests therein of Debtor in favor of the New Secured Party under the A&R Security Agreement and the Trademark Agreement, as each of the same may be further amended, modified, or restated from time to time.
