RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (the "Agreement") is made as of September 21, 2016, by and between CENTRAL FIBER LLC, a Delaware limited liability company ("Grantor"), and MARQUETTE BUSINESS CREDIT SPE I, LLC, a Minnesota limited liability company, as assignee of Marquette Business Credit, Inc., a Minnesota corporation ("Secured Party"), with reference to the following facts:

RECITALS

A. Secured Party and Grantor are parties to the Intellectual Property Security Agreement, dated as of April 20, 2012 (the "IP Security Agreement"), pursuant to which Grantor granted Secured Party a security interest in all of its Collateral (as defined in the IP Security Agreement) to secure the obligations of Borrower under the Loan Agreement (as defined below).

B. The IP Security Agreement makes reference to that certain Loan and Security Agreement, dated as of April 20, 2012 (as amended, modified or supplemented from time to time, the "Loan Agreement") by and between Secured Party and Grantor.

C. Since the filing of the IP Security Agreement, Grantor has fulfilled all of its obligations to Secured Party under the Loan Agreement and the IP Security Agreement, as evidenced by the UCC termination filed on January 13, 2016 (attached hereto as Schedule B).

D. The IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 004768, Frame 0615 on May 1, 2012.

E. The Grantor has requested that the Secured Party enter into this Agreement in order to record the release and reassignment to the Grantor of any and all right, title and interest the Secured Party may have in the Collateral pursuant to the IP Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Secured Party agree as follows:


1. Defined Terms. Any and all initially capitalized terms used in this Agreement (including, without limitation, in the recitals hereto) without definition shall have the respective meanings specified in the IP Security Agreement.
2. Release of Security Interest. Secured Party hereby terminates the IP Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the IP Security Agreement in any and all right, title and interest of the Grantor, and reassigns to the Grantor without recourse, representation or warranty any and all right, title and interest that it may have, in, to and under the Collateral, including specifically, but not limited to, the Trademarks described on Schedule A to this Agreement.


