**TERMINATION OF TRADEMARK SECURITY AGREEMENT  
AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of September 21, 2016, is made by and among Cerberus Business Finance, LLC, as collateral agent for itself and the other Secured Parties ("Grantee"), in favor of Aurora Diagnostics, LLC (collectively the "Grantor") as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to the Trademark Security Agreement dated July 31, 2014 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on July 31, 2014 at Reel/Frame No. 005334/0433-0439, the Grantor granted to the Grantee a continuing security interest in all right, title and interest of the Grantor in, to and under the trademarks listed in Schedule A of the Security Agreement (the "Trademarks"), together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reasons of infringement thereof and any and all damages arising from past, present and future violations thereof ( the "Collateral) to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

WHEREAS, the Grantor has requested that the Grantee release its continuing security interest in, all right, title and interest of the Grantee in and to the mark CAREDX, Application No. 77/958,561 listed in Schedule A (the "CAREDX Mark").

AND WHEREAS, the Grantee has no objection to releasing its continuing security interest in the CAREDX Mark.

NOW, THEREFORE, the Grantee, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its continuing security interest in the CAREDX Mark and all of the goodwill of the business connected with the use of, and symbolized by the Trademark and any and right, title and interest of the Grantee in the CAREDX Mark shall hereby terminate, cease and become void.

The Grantee agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Grantee's security interest in the CAREDX Mark (without recourse, representation or warranty and at the Grantor's sole cost and expense).
