MEMORANDUM OF CONTINUANCE

1. The liability of the members of the Company is limited to the amount (if any) for the time being unpaid on the shares respectively held by them.
2. The Company is an exempted company as defined by the Companies Act 1981.
3. The authorised share capital of the Company is US\$50,000.10 divided into 5,000,010 shares of US\$0.01 each.
4. The Company, with the consent of the Minister of Finance, has power to hold land situate in Bermuda not exceeding _____ in all, including the following parcels:-



5. Details of Incorporation: The Company was incorporated in Cayman on 10 December 2012 under the name "Global Atlantic Financial Life Limited".
6. The objects of the Company from the date of continuance are unrestricted and the Company has the capacity rights, powers and privileges:
 - (i) of a natural person;
 - (ii) subject to the provisions of Section 42 of the Companies Act 1981, to issue preference shares which at the option of the holders thereof are to be liable to be redeemed;

- (iii) to purchase its own shares in accordance with the provisions of Section 42A of the Companies Act 1981; and
- (iv) to acquire its own shares to be held as treasury shares in accordance with the provisions of Section 42B of the Companies Act 1981.

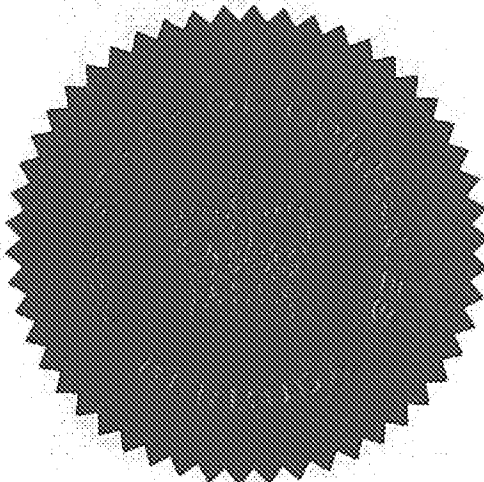

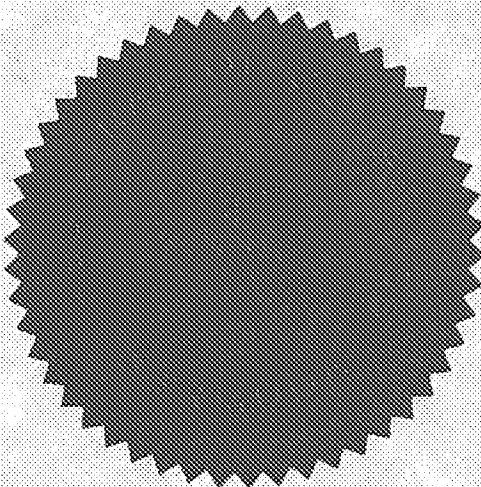
