NOW THEREFORE, for valuable consideration the receipt and sufficiency of which is hereby acknowledged, Levine does hereby assign and set over to FHE all right, title and interest in and to the Trademarks throughout the World, together with the goodwill associated with the Trademarks, all rights to sue for past, present and future infringements or misappropriations of the Trademarks, and all damages hereafter due or payable to Levine with respect to the Trademarks, including without limitation, damages and payments for past or future infringements and misappropriations of the Trademarks, with the intent that the title to such Trademarks and any related trademark

registrations and/or future trademark applications shall be fully vested in FHE, its successors and assigns.


