RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this “Release”) is made as of September 27, 2016 by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent and collateral agent (in such capacity, the “Agent”) for the Lenders (as defined in the Credit Agreement referred to in the Security Agreement (as defined below)).

W I T N E S S E T H:

WHEREAS, ALIANTE GAMING, LLC, a Nevada limited liability company (“Grantor”), and certain other entities executed that certain Security Agreement, dated as of April 25, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of the Agent, pursuant to which the Grantor granted a security interest to the Agent in certain trademarks and other intellectual property of Grantor;


