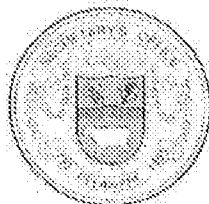

- 5.) The name of the Limited Liability Company as set forth in its certificate of formation is "Donnelley Financial, LLC".


