RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this “Release”) is made effective as of September 27, 2016, by and from Bank of America, N.A., as Administrative Agent (“Agent”) to Outerwall Inc. (f/k/a Coinstar, Inc.), a Delaware corporation (“Borrower”) as follows:

WHEREAS, on November 20, 2007, Agent, Borrower, and certain other parties entered into that certain Credit Agreement (as amended, restated, supplemented or otherwise modified from time to time, including as of April 29, 2009, July 15, 2011, and June 24, 2014, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, on November 20, 2007, Borrower and certain of its subsidiaries entered into that certain Guarantee and Collateral Agreement (as amended, restated, supplemented or otherwise modified from time to time, including as of June 24, 2014, the “Guarantee and Collateral Agreement”), granting Agent a security interest in its Intellectual Property including Trademarks, Patents, and Copyrights (each as defined therein);

WHEREAS, on November 20, 2007, pursuant to the Guarantee and Collateral Agreement, Borrower entered into that certain Grant of Security Interest in Trademark Rights, recorded in the United States Patent and Trademark Office (“USPTO”) at Reel 3672, Frame 0727 on December 6, 2007 (as amended, restated or supplemented from time to time, including as of July 15, 2011, recorded in the USPTO at Reel 4590, Frame 0612 on July 26, 2011, as of August 30, 2013, recorded in the USPTO at Reel 5116, Frame 0327 on September 6, 2013, and as of June 24, 2014, recorded in the USPTO at Reel 5310, Frame 0111 on June 26, 2014, collectively, the “Trademark Security Agreement”);

WHEREAS, on November 20, 2007, pursuant to the Guarantee and Collateral Agreement, Borrower entered into that certain Grant of Security Interest in Patent Rights, recorded in the USPTO at Reel 020196, Frame 0811 on December 6, 2007 (as amended, restated or supplemented from time to time, including as of July 15, 2011, recorded in the USPTO at Reel 026648, Frame 0521 on July 26, 2011, as of August 30, 2013, recorded in the USPTO at Reel 031171, Frame 0882 on September 6, 2013, and as of June 24, 2014, recorded in the USPTO at Reel 033245, Frame 0574 on June 26, 2014, collectively, the “Patent Security Agreement”);

WHEREAS, on July 15, 2011, pursuant to the Guarantee and Collateral Agreement, Borrower entered into that certain Grant of Security Interest in Copyrights, recorded in the United States Copyright Office (“USCO”) at Volume 3606, Document 134 on July 25, 2011 (together with all amendments thereto, if any, the “Copyright Security Agreement”);

WHEREAS, as of even date herewith, all amounts owing and due under the Credit Agreement were repaid, and upon such payment all security interests granted to Agent under the Guarantee and Collateral Agreement, the Trademark Security Agreement, the Patent Security Agreement, and the Copyright Security Agreement were automatically released and terminated; and

WHEREAS, Agent wishes to further evidence its release of its interest in the Intellectual Property, including but not limited to the Trademarks, Patents, and Copyrights (and including, without limitation, those items listed on Appendix 1), and retransfer and reassign to Borrower without recourse all of Agent’s right, title and interest in and to such Intellectual Property.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Definitions. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement, Credit Agreement, Trademark Security Agreement, Patent Security Agreement and Copyright Security Agreement, as applicable.

2. Release of Security Interest. Agent hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Intellectual Property, including but not limited to the Trademarks, Patents, and Copyrights (and including, without limitation, those items listed on Appendix 1), including any goodwill of the business symbolized by the foregoing, and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Borrower.

3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.
