**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of September 28, 2016 and made by **ARES CAPITAL CORPORATION**, a Maryland corporation, as administrative agent ("Agent" and "Grantee"), located at 245 Park Avenue, 44th Floor, New York, NY 10167 to ADG, LLC, a Michigan limited liability company ("Grantor"), located at 300 East Long Lake Road, Suite 311, Bloomfield Hills, Michigan 48304.

WHEREAS, pursuant to that certain (i) Intellectual Property Security Agreement, dated as of October 20, 2011, made by the Grantor in favor of the Grantee (the "IP Security Agreement") and (ii) Trademark Security Agreement, dated as of September 13, 2013, made by the Grantor in favor of the Grantee (the "Trademark Security Agreement" and, together with the IP Security Agreement, the "Security Agreements"; defined terms used herein without definition shall have the meanings assigned to them in the Security Agreements), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, (i) the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 20, 2011, at Reel 4645 and Frame 0286 and (ii) the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 16, 2013, at Reel 5111 and Frame 0965;

WHEREAS, the Obligations under the Credit Agreement, dated as of October 20, 2011 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Grantor, the Grantee and the other Credit Parties from time to time party thereto, have been indefeasibly satisfied in full, the Grantee's obligation to make credit extensions under the Credit Agreement have terminated, and Grantee now desires to terminate and release the Security Agreements;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in, to and under the trademarks listed on Schedule A hereto and the other Trademark Collateral (as defined in each Security Agreement).

2. Release of Security Interest. Grantee hereby terminates the Security Agreements and terminates, releases and discharges its security interest in the Trademarks and other Trademark Collateral (as defined in each Security Agreement) and re-assigns to the Grantor any and all such right, title and interest that it may have in, to and under the Trademarks and the other Trademark Collateral.


