**CERTIFICATE OF TRANSFER

This Certificate of Transfer of American Pad & Paper LLC (the "Company"), dated as of August 30, 2016, is being duly executed and filed by Maureen Kopp, as an authorized person of the Company, to transfer the Company to another jurisdiction as permitted under the Delaware Limited Liability Company Act (6 Del. C. §18-213), as amended.

1. The name of the Company is American Pad & Paper LLC, and the name under which its certificate of formation was originally filed was Pad and Paper of America LLC.

2. The original certificate of formation of the Company was filed with the Secretary of State of the State of Delaware on July 20, 2000.

3. The jurisdiction to which the Company shall be transferred is Mexico. The name of the entity formed as consequence of the transfer of the Company is RRD (Europe) S. de R.L. de C.V.

4. The transfer of the Company to the jurisdiction specified above shall be effective upon the filing of this Certificate of Transfer with the Secretary of State of the State of Delaware.

5. The transfer of the Company has been approved in accordance with the provisions of 6 Del. C. §18-213 and the laws of Mexico.

6. The existence of the Company as a limited liability company of the State of Delaware shall cease when this Certificate of Transfer becomes effective.

7. The Company agrees that it may be served with process in the State of Delaware in any action, suit or proceeding for enforcement of any obligation of the Company arising while it was a limited liability company of the State of Delaware, and irrevocably appoints the Secretary of State as its agent to accept service of process in any such action, suit or proceeding.
