**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of September 28, 2016 and made by **GENERAL ELECTRIC COMPANY** (as successor in interest by merger to General Electric Capital Corporation), as the administrative agent ("Administrative Agent" and "Grantee"), located at 500 West Monroe Street, Chicago, Illinois 60661, to **III US HOLDINGS, LLC**, a Delaware limited liability company, **INNOVATIVE INTERFACES INCORPORATED**, a California corporation, **INNOVATIVE INTERFACES IC-DISC, INC.**, a Nevada corporation and **SKYRIVER TECHNOLOGY SOLUTIONS LLC**, a California limited liability company (each a "Grantor" and, collectively, "Grantors"), located at 5850 Shellmound Way, Emeryville, California 94608.

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of February 29, 2012, made by the Grantors in favor of the Grantee (the "Security Agreement"; defined terms used herein without definition shall have the meanings assigned to them in the Security Agreement), a security interest was granted by the Grantors to the Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 29, 2012, at Reel 4726 and Frame 0643; and

WHEREAS, the Obligations under the Credit Agreement, dated as of February 29, 2012 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Grantors, the Grantee and the other Credit Parties from time to time party thereto, have been indefeasibly satisfied in full, the Grantee's obligation to make credit extensions under the Credit Agreement has terminated, and Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in, to and under the trademarks listed on Schedule A hereto and the other Trademark Collateral (as defined in the Security Agreement).

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in and re-assigns to the Grantors any and all such right, title and interest that it may have in, to the following Trademark Collateral:

- a) all of its Trademarks, including, without limitation, those referred to on Schedule A hereto;
- b) all renewals and extensions of the foregoing;
- c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- d) all income, royalties, and proceeds at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.



