RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This Release and Termination of Security Interest in Trademarks (“Release”) is given on this 28th day of September 2016, by **TPG SPECIALTY LENDING, INC.** for itself and as collateral agent (in such capacity, the “Collateral Agent”), in favor of the Grantors (as defined below), as follows:

WHEREAS, **HARMONY INFORMATION SYSTEMS, INC.** (nka Mediware Human & Social Services, Inc.), a Delaware corporation with an address at 11700 Plaza America Drive, Suite 1000, Reston, Virginia 20190, entered into a certain trademark security agreement dated June 10, 2014 with **TPG SPECIALTY LENDING, INC.**, a Delaware corporation (the “Collateral Agent”), notice of which was recorded on June 11, 2014 at the United States Patent and Trademark Office at Reel 5300, Frame 0327;

WHEREAS, **MEDISERVE INFORMATION SYSTEMS, INC.** (nka Mediware Rehabilitation & Respiratory, Inc.), a Delaware corporation with an address at 585 North Juniper, Suite 100, Chandler, Arizona 85226, entered into a certain trademark security agreement dated December 11, 2012 with the Collateral Agent, notice of which was recorded on December 11, 2012 at the United States Patent and Trademark Office at Reel 4916, Frame 0970;

WHEREAS, **BOWMAN SYSTEMS L.L.C.**, a Louisiana limited liability company with an address at 333 Texas Street, Suite 300, Shreveport, Louisiana 71101, entered into a certain trademark security agreement dated May 25, 2016 with the Collateral Agent, notice of which was recorded on June 7, 2016 at the United States Patent and Trademark Office at Reel 5808, Frame 0823;

WHEREAS, **MEDIWARE INFORMATION SYSTEMS, INC., MEDIWARE ALTERNATE CARE SOLUTIONS, INC. AND STRATEGIC HEALTHCARE GROUP, LLC**, all of which are now known as Mediware Information Systems, Inc. (the “Company”), a New York corporation with an address at 11711 West 79th Street, Lenexa, Kansas 66214, entered into a certain trademark security agreement dated November 9, 2012 with the Collateral Agent, notice of which was recorded on November 12, 2012 at the United States Patent and Trademark Office as Reel 4898, Frame 0628;

WHEREAS, pursuant to the trademark security agreements identified above (each, a “Security Agreement,” and collectively, the “Security Agreements”), each of Harmony Information Systems, Inc., Mediserve Information Systems, Inc., Bowman Systems L.L.C., Mediware Information Systems, Inc., Mediware Alternate Care Solutions, Inc. and Strategic Healthcare Group, LLC (each, a “Grantor,” and collectively, the “Grantors”) granted to the Collateral Agent a continuing security interest in all of such Grantor's right, title and interest in, to and under its trademarks and service marks, including those set forth on the attached Schedule A through Schedule D (collectively, the “Trademarks”), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, any and all causes of action by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the “Trademark Collateral”); and

WHEREAS, pursuant to the Payoff Letter, dated as of September 28, 2016, by and between, among others, the Company, the lenders party thereto and the Collateral Agent, the Company has requested and the Collateral Agent has agreed to (a) release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Security Agreements in the Trademark Collateral, (b) release and relinquish its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Trademark Collateral, including the goodwill of the business symbolized by the Trademarks and (d) assign, transfer and convey to Grantors any interest in such Trademark Collateral, including its security interest and any other liens. The Collateral Agent hereby authorizes the Company, and any of its designees, to file this Release and other necessary filings with the United States Patent and Trademark Office to effect the release and termination of the security interest in the Trademark Collateral contemplated hereby.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
