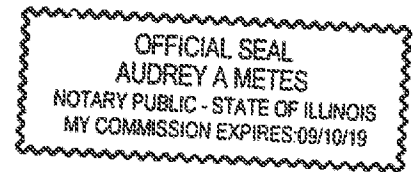
Assignee desires to acquire the business of Assignor in connection with which Assignor has a *bona fide* intent to use the Trademark and the pending Application.
