**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of September 26, 2016 ("Release"), is made by Business Development Corporation of America, as Administrative Agent ("Administrative Agent") in favor of Kineto Wireless, LLC, a Delaware limited liability company, Taqua, LLC, a Texas limited liability company, and Taqua WBH, LLC, a Delaware limited liability company (each a "Grantor", and collectively, the "Grantors").

WHEREAS, pursuant to that certain Security and Pledge Agreement dated as of July 31, 2014 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantors, Administrative Agent, and others party thereto, each Grantor granted to the Administrative Agent, for the ratable benefit of the Lenders, a continuing security interest in such Grantor's right, title and interest in and to all Patents, Patent Licenses, Trademarks, Trademark Licenses, and Proceeds of the foregoing (collectively, "IP Collateral"); and

WHEREAS, pursuant to the Security Agreement, Grantors executed and delivered to Administrative Agent, for the benefit of the Lenders, the Notice of Grant of Security Interest in Intellectual Property recorded at the United States Patent and Trademark Office ("USPTO") on August 7, 2014 at Reel 033492 Frame 0826, on August 7, 2014 at Reel 033492 Frame 0956, on August 7, 2014 at Reel 033493 Frame 0061, on August 7, 2014 at Reel 5338 Frame 0958, and on August 7, 2014 at Reel 5339 Frame 0001 ("Notice").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lenders, and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to each Grantor's right, title, and interest in, to, and under all the IP Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and


(b) authorizes the recordation of this Release with the USPTO at Grantors' expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
