**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this "Agreement") is entered into as of this  
Sep 29, 2016 ("Effective Date") by and between

KEVIN FARO of  
9509 Sundial Drive, Las Vegas, NV 89134 (the "Assignor"), and  
Mota Group, Inc. at PO Box 1116, Campbell, CA 95009  
(the "Assignee").

1. **MARK.** The term "Mark" as used in this Agreement shall mean the registered trademark **SIN (Registration No. 4602976 under Classes 005 and 030)** and all registration and application rights associated with this Mark as well as all rights to prepare derivative marks, together with all the goodwill of the business symbolized thereby, and all other rights in the United States and in all countries and territories worldwide and under any international convention.
2. **CONSIDERATION.** Assignee shall pay Assignor the sum of \$1, payable on the Effective Date in consideration for the assignment of the Mark.
3. **EXECUTION AND DELIVERY.** After Assignee pays the amount due, Assignor shall execute and deliver to Assignee any and all instruments of sale, transfer, conveyance, assignment, and confirmations as Assignee may lawfully request in order to obtain, perfect, maintain, or otherwise enable the transfer, conveyance, and assignment to Assignee and to confirm Assignee's title to the Mark and any and all related federal trademark registrations and/or application rights.
4. **ENTIRE AGREEMENT.** This Agreement constitutes the entire agreement between Assignor and Assignee and supersedes all prior understandings of Assignor and Assignee.
5. **MODIFICATOIN AND WAIVER.** This Agreement may be amended or modified only by a written agreement signed by both of the parties. Neither party will be charged with any waiver of any provision of this Agreement, unless such waiver is evidenced by a writing signed by the party and any such waiver will be limited to the terms of such writing.
6. **SEVERABILITY.** If any provision of this Agreement is held to be invalid or unenforceable in whole or in part, the remaining provisions shall not be affected and shall continue to be valid and enforceable as though the invalid or unenforceable parts had not been included in this Agreement.
7. **JURISDICTION.** This Agreement shall be governed by the laws of the State of California, the County of Santa Clara.
8. **SUCCESSORS AND ASSIGNS.** This Agreement will inure to the benefit of and be binding on the respective successors and permitted assigns of the parties.
