GRANT OF SECURITY INTEREST IN TRADEMARKS

All proceeds, products, rents and profits of or from any and all the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Agent is the loss payee), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise in respect of any of the foregoing Trademark Collateral. For these purposes, the term "Proceeds" includes whatever is received or receivable when any Trademark Collateral or other proceeds are sold, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.


Grantor has granted the security interest under this instrument pursuant to the terms of a Forbearance Agreement, dated as of January 21, 2016 (as may be amended, restated and/or modified from time to time, the "Forbearance Agreement"), made by Grantor and Immuno Concepts N.A., Ltd., in favor of Secured Party for the purposes of security as provided in the Forbearance Agreement. Grantor acknowledges and affirms that the rights, privileges and remedies of the Secured Party with respect to the security interest in the Trademark Collateral granted in this instrument are more fully set forth in the Forbearance Agreement, the terms and provisions of which are incorporated in this instrument by this reference.
