TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is dated effective 16 August 2012 by and between Emergency Medical Certification, Inc., a Texas corporation, d/b/a EmCert Incorporated, with principal address of 2071 Moore Road, Beaumont, Texas 77713 (the "Assignor"), and Medic-CE.com, LLC, a Nevada limited liability company, with principal address of PO Box 540141, Houston, TX 77254 (the "Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. *Assignment.* Assignor does hereby assign unto Assignee, with full title guarantee and free from all encumbrances and third party rights, all right, title and interest in and to the Mark and U.S. Trademark Registration No. 2,435,063, throughout the world, together with the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark, and any and all common law rights thereto, the right to apply for the registration thereof, the right to bring, make, oppose, defend and appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership of the Mark whether occurring before, on or after the date of this Trademark Assignment.

2. *Future Cooperation.* Assignor agrees to cooperate to execute all papers and perform such other acts as may be reasonably necessary to give Assignee and its successors and assigns the full benefit of this Trademark Assignment.
