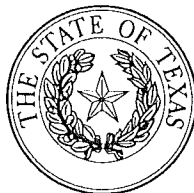

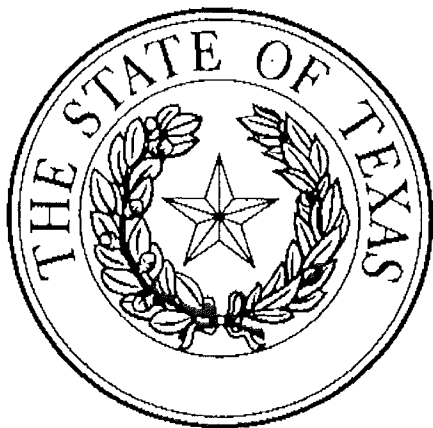

The undersigned person, acting as organizer of a limited liability company ("*Company*") under the Texas Business Organizations Code (as amended, the "*TBOC*"), hereby adopts the following Certificate of Formation for the Company:

**ARTICLE I**  
**NAME**

The name of the Company is Medic-CE.com LLC.

**ARTICLE II**  
**ENTITY**

The filing entity being formed is a limited liability company.

**ARTICLE III**  
**PURPOSE**

The purpose for which the Company is organized is for the transaction of any and all lawful business for which limited liability companies may be organized under the TBOC.

**ARTICLE IV**  
**ORGANIZATION**

The Company is being formed pursuant to a certain Plan of Conversion dated March 7, 2014. The managers may purchase, on behalf of the Company, such liability, indemnification and/or other similar insurance as the board of managers, in its sole discretion, shall determine is necessary or appropriate from time to time. No amendment, modification, or repeal of this provision will apply to or adversely affect any right or protection of any Indemnified Person hereunder for or with respect to any acts or omissions of the Indemnified Person occurring prior to such amendment, modification or repeal.
