RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**") is made as of September 30, 2016, by The Northwestern Mutual Life Insurance Company, as Administrative Agent and Collateral Agent (the "**Administrative Agent**"), pursuant to that certain Trademark Security Agreement, dated as of July 9, 2015 among KidKraft, Inc., as grantor (the "**Grantor**"), and Administrative Agent (as amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"). Capitalized terms used herein have the meanings attributed thereto in the Security Agreement unless otherwise defined herein.

WHEREAS, the Grantor and the Administrative Agent entered into the Security Agreement, whereby Grantor granted to the Administrative Agent a security interest in all of Grantor's right, title and interest in the Trademark Collateral (as defined in the Security Agreement), including the trademarks and trademark applications listed on Schedule A (the "**Released Collateral**");

WHEREAS, the Security Agreement was recorded in the U.S. Patent and Trademark Office on July 24, 2015 at Reel 5584, Frame 0772; and

WHEREAS, in accordance with the provisions of the Security Agreement, the Grantor has requested and the Administrative Agent has agreed to release, discharge, relinquish, terminate and dissolve its security interest in all of Grantor's right, title and interest in and to the Released Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. **Release of Security Interest.** The Administrative Agent hereby terminates, releases and discharges its security interest in the Released Collateral; any and all claims for damages for past, present and future infringement, misappropriation or breach with respect to the Released Collateral, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; any and all proceeds of the foregoing; and any right, title or interest of the Administrative Agent in such Released Collateral is hereby void.

2. **Further Assurances.** The Administrative Agent agrees to execute and deliver to Grantor, at Grantor's sole cost and expense, any and all further documents and instruments, and do any and all further acts, which Grantor (or its agents or designees) reasonably requests (at Grantor's sole cost and expense) in order to confirm this Release.

3. **Recordation of Release.** The Administrative Agent hereby authorizes Grantor or Grantor's authorized representative to record this Release with the U.S. Patent and Trademark Office.

4. **Electronic Execution.** This Release may be executed by facsimile transmission or other electronic transmission.


