1. I hold the title of Director with Fred Perry (Holdings) Limited ("Assignee"). I am authorized to make this declaration on behalf of Assignee, and the facts set forth in this declaration are based on my firsthand knowledge.
2. I am familiar with the assignment document recorded on January 26, 1996 at reel/frame 1396/0281 (the "Assignment"), which assigns certain trademark registrations from assignor Fred Perry Sportswear Limited ("Assignor") to Assignee.
