NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to the Trademark Security Agreements listed on Schedule I hereto, recorded at the Reel and Frame location set forth on Schedule I hereto, each entity listed on the signature pages thereto (each a “**Grantor**” and, collectively, the “**Grantors**”) assigned and granted in favor of General Electric Company (as successor in interest by merger to General Electric Capital Corporation), as Administrative Agent for the Lenders (in such capacity, the “**Administrative Agent**”), a security interest in such Grantor’s right, title and interest in and to the applicable trademarks listed on Schedule II hereto (the “**Trademark Collateral**”);

WHEREAS, pursuant to the Payoff Letter, dated as of September 30, 2016, by and among the Administrative Agent, DTI Holdco, Inc., a Delaware corporation (the “**Company**”), and the other parties thereto, the Company has requested and the Administrative Agent has agreed to procure, execute and deliver to the Company, at the expense of the Company, this Notice of Release of Security Interest in Trademarks confirming and carrying out the release and discharge of the Secured Parties’ security interest in the Trademark Collateral; and

WHEREAS, the Administrative Agent wishes to terminate and release its security interest in the Trademark Collateral.


