**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of August 1, 2016, and made by RENASANT BANK ("Lender"), to EVERMARK LLC, a Georgia limited liability company ("Evermark"), and LNL BUILDING PRODUCTS (GEORGIA) LLC, a Georgia limited liability company ("LNL" and, together with Evermark, the "Companies").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 15, 2014 made by Companies in favor of Lender (the "Security Agreement"), a security interest was granted by the Companies to Lender in certain trademark collateral, including the trademarks, including without limitation those trademarks referred to on Schedule 1 hereto, ;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 17, 2014, at Reel 005364 and Frame 0168; and

WHEREAS, Lender now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Lender hereby states as follows:

1. Definitions. Capitalized terms used herein shall have the meanings assigned to them in the Security Agreement, unless a different meaning is assigned to such term(s) herein.

2. Release of Security Interest. Lender hereby terminates the Security Agreement and terminates releases and discharges its security interest in the Trademark Collateral, including without limitation those Trademarks referred to on Schedule 1 hereto, and reassigns to the person or persons legally entitled thereto all right, title and interest of Lender in the Trademark Collateral.
