RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of September 29, 2016 (this "Release") is made by Comerica Bank, a Texas banking association, as agent for and on behalf of the Lenders (the "Secured Party"), under the Intellectual Property Security Agreement dated as of August 14, 2007 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Duraflame, Inc., a California corporation and Wonderfuel, LLC, a Kentucky limited liability company (collectively, the "Debtors") and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 5761, Frame 0323.

WHEREAS, pursuant to the Security Agreement, the Debtors granted to the Secured Party a security interest in the Debtors' trademarks, including but not limited to the trademarks listed on attached Schedule A (the "Trademarks").

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Debtors; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
