**NOTICE OF TRADEMARK SECURITY AGREEMENT  
(FOR RECORDATION PURPOSES)**

This Notice of Trademark Security Agreement, dated as of September 6, 2016, is made with regard to JAGEMANN STAMPING COMPANY, a Wisconsin corporation ("Borrower"), having an address for notice at 5757 West Custer Street, Manitowoc, Wisconsin 54221, and BMO HARRIS BANK N.A., a national banking association ("Lender"), having an address for notice at 310 West Walnut Street, Green Bay, Wisconsin 54303.

RECITALS:

The Borrower and the Lender are parties to a 2016 Amended and Restated Credit Agreement dated as of September 6, 2016 (as the same may hereafter be amended, supplemented or restated from time to time, the "Credit Agreement") setting forth the terms on which the Lender may now or hereafter make certain loans or other financial accommodations to or for the account of the Borrower.

As a further condition to making any loan or other financial accommodation under the Credit Agreement or otherwise, the Lender has required the execution and delivery of a Security Agreement (the "Security Agreement") by the Borrower.

ACCORDINGLY, in consideration of the mutual covenants contained in the Credit Agreement, the Trademark Security Agreement, and herein, the undersigned gives notice as follows:

Pursuant to the terms of the Security Agreement, Borrower has granted a security interest in favor of the Lender in and with respect to the entire right, title, and interest of Borrower in the trademarks identified in the attached schedule (the "Trademarks"), together with the goodwill of the business symbolized by said Trademarks.

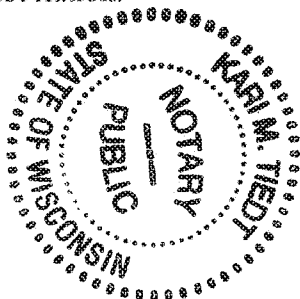
