**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release") is dated as of September 19, 2016 by WILMINGTON TRUST, NATIONAL ASSOCIATION, successor by merger to WILMINGTON TRUST FSB, as Collateral Trustee (the "Collateral Trustee"), in favor of SAFWAY SERVICES, LLC, a Delaware limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Grantor and the Collateral Trustee entered into that certain Pledge and Security Agreement dated as of December 16, 2009 (as amended, restated, amended and restated, modified or supplemented from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantor executed and delivered to the Collateral Trustee that certain Trademark Collateral Assignment and Security Agreement, dated as of February 22, 2013 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on February 26, 2013 at Reel/Frame No. 4970/0928, pursuant to which the Grantor granted to the Collateral Trustee, for the benefit of itself and the other Parity Lien Secured Parties, a continuing security interest in and a general lien upon, and collaterally assigned and transferred to the Collateral Trustee, for the benefit of itself and the other Parity Lien Secured Parties, its Trademarks (as defined in the Trademark Security Agreement) and Collateral (as defined in the Trademark Security Agreement);


WHEREAS, the Grantor has requested that the Collateral Trustee release its security interest and general lien in and to the Trademarks and Collateral in connection with the termination of the Pledge and Security Agreement and the Trademark Security Agreement.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Trustee hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest and general lien in and to the Trademarks and Collateral, including the trademark registrations and applications set forth in Schedule I, attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademarks and Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Trustee may have obtained in, to and under the Trademarks and Collateral under the Pledge and Security Agreement.


