

**TERMINATION AND RELEASE OF  
GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of September 2, 2016, and made by Medley Bank, SBIC, LP, as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent") having an office at 280 Park Avenue, 6th Floor East, New York, NY 10017, to Untangle, Inc., a Delaware corporation ("Grantor").

WHEREAS, pursuant to the Trademark Security Agreement dated as of April 18, 2014 by the Grantor named therein and the Collateral Agent (the "Trademark Security Agreement") certain security interests (the "Interests") were granted by the Grantor to the Collateral Agent in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Assignment Division of the United States Patent and Trademark Office as set forth on Schedule A hereto;

WHEREAS, Grantor requested that Collateral Agent terminate and release the Interests; and

NOW, THEREFORE, for good and valuable consideration, Collateral Agent hereby states as follows:

1. Definitions. The term "Trademarks", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the Trademark Security Agreement, or if not defined in the Trademark Security Agreement, are used as defined in that certain Security Agreement referenced therein.


2. Release of Security Interest. The Collateral Agent hereby terminates the Interests and terminates, releases and discharges its interest in the Trademarks.
