The Administrative Agent hereby authorizes the Grantors or the Grantors' authorized representatives to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Administrative Agent agrees to execute and deliver to the Grantors, at the Grantors' expense, all other instruments and other documents as may be reasonably necessary or proper to release the security interest in the Trademark Collateral which had been granted under the Trademark Security Agreement. All capitalized terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Trademark Security Agreement.
