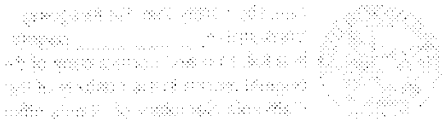
1. They are the President and Secretary of Diageo Chateau & Estate Wines Company, a California corporation (the "Corporation").
