RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made and entered into as of September 30, 2016 (“Effective Date”) by and between, Fantail Irrevocable Trust 2012, a New Hampshire Trust having an address of 4 Quentin Drive, Brookline, New Hampshire, 03033 (“Fantail”), and TUI Irrevocable Trust of 2012, a New Hampshire Trust having an address of 4 Quentin Drive, Brookline, New Hampshire, 03033 (“TUI”) (Fantail and TUI each a “Lender” and collectively the “Lenders”), and INNOVAIRRE COMMUNICATIONS, LLC, a Delaware corporation having an office at 2370 State Route 70 West, Suite 200, Cherry Hill, NJ 08002 (“Grantor”).

WHEREAS, each Lender is the holder of a continuing security interest in and to all of Grantor’s right, title and interest in, to and under the trademarks, service marks and related applications and registrations set forth in Schedule 1 attached hereto connected with the use of or related to any and the foregoing (including without limitation, all goodwill of the Grantor and its business, products and services appurtenant to, associated with or symbolized by any of the foregoing and the use thereof), together with all registrations of the foregoing and the applications therefor (collectively, the “Trademark Collateral”) pursuant to that certain Security and Pledge Agreement dated June 27, 2014, for which a Notice of Grant of Security Interest is recorded with the United States Patent and Trademark Office at Reel 5510, Frame 0870 (the “Security Agreement”); and

WHEREAS, Grantor desires to record this instrument to evidence termination of the security interest.


NOW, THEREFORE, the Grantor and Lenders agree as follows:

1. The Lenders hereby expressly release and discharge, the security interest in, to and under the Trademark Collateral pursuant to the Security Agreements.
2. The Lenders hereby authorize and request the Commissioner of Patents and Trademarks to record this Release in the United States Patent and Trademark Office with regard to the Security Agreement and the Trademark Collateral.
3. This Release may be executed in multiple counterparts, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.
