**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated September 13, 2016 by BANK OF AMERICA, N.A. ("*Lender*"), with its mailing address at 135 South LaSalle Street, 9th Floor, Chicago, Illinois 60603;

**WITNESSETH:**

WHEREAS, AFNI, INC, an Illinois corporation ("*Grantor*") with its principal place of business and mailing address at 404 Brock Drive, Bloomington, Illinois 61702 and Lender were parties to a certain Trademark Security Agreement dated April 29, 2013 between Grantor and Lender which was recorded in the United States Patent and Trademark Office on May 8, 2013 at Reel 5022, Frame 0953 (the "*Agreement*"), pursuant to which Grantor granted to Lender, a security interest in, among other things, trademark and trademark licenses listed on Schedule I attached hereto and certain other property (collectively, the "*Trademark Collateral*"); and

Lender hereby releases its security interests in, and hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Lender, all of its right, title and interest, if any, in and to each trademark registration, and trademark application listed on Schedule I hereto, including:

- (i) all of its trademarks and all trademark licenses to which it is a party, including without limitation, those referred to on Schedule I;
- (ii) all renewals of the foregoing;
- (iii) all goodwill of the business connected with the use of, and symbolized by, each trademark and trademark license; and
- (iv) all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any trademark or any licensed trademark or (ii) injury to the goodwill associated with any trademark or any licensed trademark.
