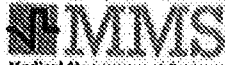

4. I make this declaration in support of Medical Measurement System B.V.'s ("Medical Measurement") correction of the invalid assignments recorded at Reel/Frame 5733/0094 and Reel/Frame 5820/0718.

5. On November 12, 2014, Lacidem Holding B.V. assigned the entire right, title and interest in and to U.S. Trademark Registration No. 3826721 and the trademark that is the subject thereof, including the goodwill connected with the use of, and symbolized, by said trademark, to MMS Holding B.V. A true and correct copy of said assignment is attached hereto as Exhibit A. The assignment was not recorded against the subject registration.

6. On April 9, 2015, MMS Holding B.V. assigned the entire right, title and interest in and to U.S. Trademark Registration No. 3826721 and the trademark that is the subject thereof, including the goodwill connected with the use of, and symbolized, by said trademark, to Medical Measurement. A true and correct copy of said assignment is attached hereto as Exhibit B. The assignment was not recorded against the subject registration.

7. In light of the April 9, 2015, assignment, U.S. Trademark Registration No. 3826721 is in the name of and owned by Medical Measurement Systems B.V.

8. On January 20, 2016, I executed an instrument purporting to assign U.S. Trademark Registration No. 3826721 and the trademark that is subject thereof from Lacidem Holding B.V. to LABORIE Canada. The instrument was recorded on January 29, 2016, at Reel/Frame 5733/0094. A true and correct copy of the cover sheet and instrument recorded at Reel/Frame 5733/0094 is attached hereto as Exhibit C.

**BETWEEN:**

- (1) **Lacidem Holding B.V.**, a private company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*) incorporated under the laws of the Netherlands, having its statutory seat (*statutaire zetel*) in Enschede, the Netherlands, registered with the trade register of the Chamber of Commerce with number 06062669 ("Lacidem");
- (2) **MMS Holding B.V.**, a private company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*) incorporated under the laws of the Netherlands, having its statutory seat (*statutaire zetel*) in Enschede, the Netherlands, registered with the trade register of the Chamber of Commerce with number 06091573; ("MMS Holding") (Lacidem and MMS Holding are hereinafter jointly also referred to as the "Assignors"); and
- (3) **Medical Measurement Systems B.V.**, a private company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*) incorporated under the laws of the Netherlands, having its statutory seat (*statutaire zetel*) in Enschede, the Netherlands, registered with the trade register of the Chamber of Commerce with number 06070224 (the "Assignee").

The parties to this Deed are hereinafter collectively referred to as the "Parties" and individually as a "Party".

**RECITALS:**

- (A) On the terms and conditions of a share purchase agreement to that effect dated on or about the date hereof, MMS Holding, the parent company of which is Lacidem, has agreed to sell and transfer all the issued and outstanding shares in the share capital in the Assignee and its affiliated companies Medical Measurement Systems – USA, Inc. and Medical Measurement Systems Deutschland GmbH to Laborie Netherlands B.V. Laborie Medical Technologies Corp. and Laborie German Holdings GmbH, respectively (the "Transaction").
- (B) Until recently, Lacidem held a number of trademarks used in relation to the Business.
- (C) By deed of assignment of 12 November 2014, Lacidem assigned and transferred its rights in a number of trademarks relating to the Business to MMS Holding.
- (D) Most of such trademarks assigned and transferred to MMS Holding are currently still registered in the name of Lacidem.
- (E) With a view to the Transaction, it is the Parties' intention that all Trademarks with respect to Business are assigned and transferred to the Assignee.
- (F) The Parties therefore enter into this Deed, pursuant to which both Lacidem and MMS Holding assign and transfer to the Assignee any and all of their rights in the Trademarks with respect to the Business.

**IT IS AGREED** as follows:

## 1. INTERPRETATION

1.1. In this Deed, the following definitions are used:

- 1.1.1. "Business" means the business of the development, sourcing, marketing, supply, distribution and sale of medical devices and related accessories used for gastroenterology and urodynamics carried on by the MMS Companies;
- 1.1.2. "Deed" has the meaning given in the first page heading of page 1 of this Deed;
- 1.1.3. "MMS Companies" means (i) the Assignee, (ii) Medical Measurement Systems – USA, Inc. and (iii) Medical Measurement Systems Deutschland GmbH jointly;
- 1.1.4. "MMS Trademarks" has the meaning given in Clause 2.1; and
- 1.1.5. "Trademarks" means registered and unregistered trademarks, logos, company names and trade names, including all trademark rights, trade name rights and other rights therein;

1.2. In this Deed, unless otherwise specified:

- 1.2.1. references to a person shall include a reference to any individual, company, association, partnership or joint venture;
- 1.2.2. references to "include" and "including" shall be treated as references to "include without limitation" or "including without limitation";
- 1.2.3. a "Clause" or a "Schedule" shall be construed as a reference to a clause or a schedule of this Deed;
- 1.2.4. unless the context requires otherwise, words in the singular shall include the plural and vice versa; and
- 1.2.5. the headings are for identification only and shall not affect the interpretation of this Agreement.

## 2. ASSIGNMENT

2.1. The Assignors hereby irrevocably, unconditionally and without limitation assign and transfer to the Assignee, and the Assignee hereby accepts, any and all of their respective right, title and interest in all Trademarks used for, or otherwise relating to, the products and services of the MMS Companies and the Business, including the Trademarks set out in Schedule 1, (all such Trademarks jointly: the "MMS Trademarks");

## 3. MISCELLANEOUS

- 3.1. The Assignors waive their respective rights to rescind (*ontbinden*) this Deed or to nullify (*vernietigen*) the (legal) acts performed under or pursuant to this Deed.
- 3.2. The Assignors undertake to do such acts and execute such (further) documents and to render all such assistance as may be reasonably required by or on behalf of the Assignee for the further assuring and vesting full right, title and interest in the MMS Trademarks in favour of the Assignee and for procuring the registration of the Assignee as the registered



proprietor of the MMS Trademarks.

- 3.3. The Assignors shall render to the Assignee, at the Assignee's first request, any reasonable assistance which the Assignee deems necessary or desirable to defend or prosecute any of the rights in the MMS Trademarks, provided that any and all reasonable costs and expenses of the Assignor shall be reimbursed by the Assignee.
