SHORT FORM LIMITED THIRD LIEN
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This LIMITED THIRD LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Limited Third Lien IP Security Agreement**") dated October 6, 2016, is made by the Persons listed on the signature pages hereof (collectively, the "**Grantors**") in favor of Wilmington Trust, National Association, as collateral agent for the Secured Parties (in such capacity, the "**Collateral Agent**"). Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned to such terms in the Indenture, the Limited Third Lien Security Agreement and the Limited Third Lien Intellectual Property Security Agreement referred to therein.

WHEREAS, KINETIC CONCEPTS, INC., a Texas corporation ("**KCI**"), KCI USA, INC., a Delaware corporation ("**KCI USA**"), each Guarantor (as defined in the Indenture) and Wilmington Trust, National Association, as Trustee (in such capacity, the "**Trustee**") and Collateral Agent have entered into the Indenture dated as of October 6, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Indenture**").

WHEREAS, in connection with the Indenture, the Grantors have entered into the Limited Third Lien Intellectual Property Security Agreement dated October 6, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Limited Third Lien Intellectual Property Security Agreement**").

WHEREAS, under the terms of the Limited Third Lien Intellectual Property Security Agreement, the Grantors have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Grant of Security. Each Grantor hereby grants to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in all of such Grantor's right, title and interest in and to the following (the "**Collateral**"):

- (a) the United States Patents (as defined in the Intellectual Property Security Agreement) set forth in Schedule A hereto;
- (b) the United States registered Trademarks (as defined in the Intellectual Property Security Agreement) and Trademarks for which United States applications are pending set forth in Schedule B hereto; and
- (c) the United States registrations of Copyrights (as such terms are defined in the Intellectual Property Security Agreement) set forth in Schedule C hereto.

SECTION 2. Security for Obligations. The grant of a security interest in the Collateral by each Grantor under this IP Security Agreement secures the payment of all Secured Obligations of such Grantor now or hereafter existing under or in respect of the Note Documents and any Additional Pari Passu Agreement, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs,

expenses or otherwise. Without limiting the generality of the foregoing, this IP Security Agreement secures, as to each Grantor, the payment of all amounts that constitute part of the Secured Obligations and that would be owed by such Grantor to any Secured Party under the Covered Documents but for the fact that such Secured Obligations are unenforceable or not allowable due to the existence of a bankruptcy, reorganization or similar proceeding involving a Grantor.

SECTION 3. Recordation. This IP Security Agreement has been executed and delivered by the Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office and the United States Copyright Office. Each Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks record this IP Security Agreement.

SECTION 4. Execution in Counterparts. This Limited Third Lien IP Security Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Limited Third Lien IP Security Agreement by facsimile transmission or other electronic communication (such as a “.pdf” or “.tif”) shall be as effective as delivery of a manually signed counterpart of this Limited Third Lien IP Security Agreement.

SECTION 5. Grants, Rights and Remedies. This Limited Third Lien IP Security Agreement has been entered into in conjunction with the provisions of the Limited Third Lien Intellectual Property Security Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Collateral Agent with respect to the Collateral are more fully set forth in the Limited Third Lien Intellectual Property Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Limited Third Lien IP Security Agreement and the terms of the Limited Third Lien Intellectual Property Security Agreement, the terms of the Limited Third Lien Intellectual Property Security Agreement shall govern.

SECTION 6. Governing Law. THIS LIMITED THIRD LIEN IP SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.


SECTION 7. Severability. In case any one or more of the provisions contained in this Limited Third Lien IP Security Agreement should be held invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions contained herein and in the Limited Third Lien Intellectual Property Security Agreement shall not in any way be affected or impaired thereby (it being understood that the invalidity of a particular provision in a particular jurisdiction shall not in and of itself affect the validity of such provision in any other jurisdiction). The parties hereto shall endeavor in good-faith negotiations to replace the invalid, illegal or unenforceable provisions with valid provisions the economic effect of which comes as close as possible to that of the invalid, illegal or unenforceable provisions.

SECTION 8. Concerning the Collateral Agent. Wilmington Trust, National Association is entering this IP Security Agreement not in its individual capacity, but solely in its capacity as Collateral Agent under the Indenture. Section 12.9 of the Indenture concerning the Collateral Agent is incorporated herein *mutatis mutandis*, except that references therein to (i) “Holders” shall be references herein to “Secured Parties” and (ii) “Issuer” and “Guarantor” shall be references herein to “Grantor” as context dictates.


