- 1. Assignment. Assignor does hereby sell, transfer, convey and assign to Assignee, free and clear, all its right, title and interest in and to the Mark, worldwide, including the goodwill of the business appurtenant thereto and which is symbolized thereby, including the right to sue for any prior infringement of the Mark. Assignor agrees to undertake any such other acts, and shall execute, acknowledge and/or deliver any such other instruments, documents and other materials, at Assignee's expense, as may be reasonably required in order to consummate the transaction and protect or enforce the rights assigned to Assignee.




