RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of October 7, 2016 (the “Effective Date”), by BANK OF AMERICA, N.A., as collateral agent (in such capacity, the “Collateral Agent”), in favor of CHOBANI, LLC (formerly known as Chobani, Inc. and by change of name from Agro-Farma, Inc.) (the “Pledgor”).

WHEREAS, pursuant to the terms and conditions of (a) that certain Security Agreement, dated as of April 6, 2011, by and among the Pledgor, the Collateral Agent and the other grantors party thereto (the “Security Agreement”) and the Notice of Grant of Security Interest in Patents delivered by the Pledgor on May 3, 2011 in connection therewith (the “First Notice of Grant of Security Interest in Trademarks”) and (b) that certain Amended and Restated Security and Pledge Agreement, dated as of June 28, 2011, by and among the Pledgor, the Collateral Agent and the other grantors party thereto (the “Amended and Restated Security Agreement” and together with the Security Agreement, the “Security Agreements”) and (i) the Notice of Grant of Security Interest in Patents delivered by the Pledgor on December 11, 2013 in connection therewith (the “Second Notice of Grant of Security Interest in Trademarks”), (ii) the Notice of Grant of Security Interest in Trademarks delivered by the Pledgor on December 11, 2013 in connection therewith (the “Third Notice of Grant of Security Interest in Trademarks”), (iii) the Notice of Grant of Security Interest in Trademarks delivered by the Pledgor on April 29, 2014 in connection therewith (the “Fourth Notice of Grant of Security Interest in Trademarks”) and (iv) the Notice of Grant of Security Interest in Trademarks delivered on April 24, 2014 by the Pledgor in connection therewith (the “Fifth Notice of Grant of Security Interest in Trademarks” and together with the Notice of Security Interest in Trademarks listed in (a) and (b)(i) through (iii) above., the “Notices of Security Interest in Trademarks”), the Pledgor pledged and granted to the Collateral Agent a lien on and security interest in all of their respective right, title and interest in and to certain collateral identified in each Notice of Security Interest in Trademarks including, without limitation, the trademarks and trademark applications set forth on Schedule I hereto, along with the goodwill associated therewith and all proceeds thereof (collectively, the “Trademarks”);

WHEREAS, the First Notice of Grant of Security Interest in Trademarks was recorded with the Assignment Division of the U.S. Patent & Trademark Office on May 3, 2011 on Reel 4532, Frame 0936;

WHEREAS, the Second Notice of Grant of Security Interest in Trademarks was recorded with the Assignment Division of the U.S. Patent & Trademark Office on December 11, 2013 on Reel 5171, Frame 0482;

WHEREAS, the Third Notice of Grant of Security Interest in Trademarks was recorded with the Assignment Division of the U.S. Patent & Trademark Office on December 11, 2013 on Reel 5171, Frame 0455;

WHEREAS, the Fourth Notice of Grant of Security Interest in Trademarks was recorded with the Assignment Division of the U.S. Patent & Trademark Office on January 2, 2013 on Reel 4933, Frame 0606;

WHEREAS, the Fifth Notice of Grant of Security Interest in Trademarks was recorded with the Assignment Division of the U.S. Patent & Trademark Office on April 29, 2014 on Reel 5270, Frame 0415;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Notices of Security Interest in Trademarks and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Trademarks arising under the Security Agreements and the Notices of Security Interest in Trademarks.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Pledgor.


