**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the "Release") is dated as of October 7, 2016 by CITIBANK N.A., a national banking association formed under the laws of the United States of America, acting through its London branch, with registered office at Citigroup Centre, Canada Square, Canary Wharf, London, E14 5LB, United Kingdom, with branch number BR001018, as Security Trustee (the "Security Trustee") for the Secured Parties (as defined in the Senior Facilities Agreement referred to below) in favor of Schoeller Allibert US, Inc., formerly known as Schoeller Arca Systems, Inc. (the "Grantor").

**WITNESSETH**

WHEREAS, Schoeller Allibert Group B.V., certain of its subsidiaries, and the Security Trustee entered into that certain Senior Facilities Agreement dated December 18, 2007 and as amended December 19, 2007 (as hereafter amended, amended and restated, supplemented or otherwise modified from time to time, the "Senior Facilities Agreement"), that certain Subordinated Bridge Facility Agreement dated December 18, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Subordinated Bridge Facility Agreement"), and that certain Intercreditor Agreement dated December 18, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Intercreditor Agreement");

WHEREAS, pursuant to the Senior Facilities Agreement and the Subordinated Bridge Facility Agreement, the Grantor executed and delivered to the Security Trustee that certain (i) Intellectual Property Security Agreement dated January 30, 2008 (the "Intellectual Property Security Agreement") and recorded with the United States Patent and Trademark Office (the "USPTO") on February 5, 2008 at Reel/Frame Nos. 20462/0764 and 3713/0351 and (ii) Intellectual Property Security Agreement Supplement dated March 4, 2009 (the "Supplement") and recorded with the USPTO on March 27, 2009 at Reel/Frame Nos. 22460/0417 and 3960/0563, pursuant to which the Grantor granted to the Security Trustee for the ratable benefit of the Secured Parties a security interest in all of its right, title and interest in and to the Collateral (as defined in the Intellectual Property Security Agreement and Supplement);

WHEREAS, the Grantor has requested that the Security Trustee release its security interest in all of its right, title and interest in, to and under the Collateral.

WHEREAS, the Parties have agreed that for the avoidance of doubt all provisions set forth in the Intercreditor Agreement relating to the indemnification, exculpation and any other rights and remedies of the Security Trustee are hereby incorporated by reference into this Agreement as if set forth herein *mutatis mutandis*.

NOW, THEREFORE, in consideration of the foregoing, the Security Trustee hereby **DISCHARGES, TERMINATES and RELEASES**, without recourse, representation or warranty, its security interest in all of its right, title and interest in, to and under the Collateral, including the patents, patent applications, and trademark registrations set forth in Schedules A and B attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Security Trustee may have obtained in, to and under the Collateral under the Senior Facilities Agreement and the Subordinated Bridge Facility Agreement.


