**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of October 7, 2016, by DEUTSCHE BANK AG NEW YORK BRANCH, a German foreign banking corporation with offices at 60 Wall Street, New York, New York 10005 (the “Collateral Agent”) in favor of ZEST IP HOLDINGS, LLC, a Delaware limited liability company with offices at 2061 Wineridge Place, Escondido, California 92029 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor, entered into a certain second lien trademark security agreement dated August 16, 2013 (the “Second Lien Trademark Security Agreement”; terms used herein but not defined herein shall have the meanings assigned to them in the Second Lien Trademark Security Agreement) with the Collateral Agent, notice of which was recorded on August 20, 2013 at the United States Patent and Trademark Office at Reel 5094, Frame 0543.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Second Lien Trademark Security Agreement and the Second Lien Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to certain of Grantor’s intellectual property, including without limitation (i) the trademarks listed in **Schedule A** (the “Trademarks”), (ii) all Proceeds and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same (collectively, the “Trademark Collateral”).

WHEREAS, the Second Lien Security Agreement has been terminated.

WHEREAS, the Grantor has requested and the Collateral Agent has agreed to terminate and release its security interest in all Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the Secured Parties, hereby:

(a) releases, terminates, discharges and cancels all of its Security Interest in and to the Trademark Collateral;


(b) transfers, conveys and assigns any and all of its right, title and interest in and to the Trademark Collateral to the Grantor; and

(c) terminates and cancels the Second Lien Trademark Security Agreement.
