TRADEMARK ASSIGNMENT

This Assignment being entered into on the Effective Date pursuant to the transactions contemplated by that certain Asset Purchase Agreement made and entered into as of February 1, 2013, by and among West Services Inc., a Delaware corporation, Transferor, Thomson Reuters Global Resources, an unlimited company organized under the laws of the Republic of Ireland, and Transferee (the "Purchase Agreement"). Capitalized terms not defined herein will have the meaning set forth in the Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Transferor and Transferee hereby agree as follows:

1. **ASSIGNMENT.** Transferor hereby sells, conveys, transfers, and assigns to Transferee Transferor's entire right, title and interest in and to the trademarks set forth in Appendix A (collectively, the "Trademarks"), together with all goodwill associated therewith and all trademark registrations, applications and renewals in connection therewith, and all claims for damages by reason of past, present or future infringement, dilution or misappropriation of the foregoing, with the right to sue for and collect the same.

2. **SUBJECT TO PURCHASE AGREEMENT.** Notwithstanding any other term herein, this Assignment is executed and delivered pursuant to the Purchase Agreement and is subject to every representation, warranty, covenant and agreement in the Purchase Agreement. All representations and warranties with respect to the Trademarks are set forth in the Purchase Agreement. NEITHER PARTY MAKES ANY WARRANTIES OR REPRESENTATIONS OF ANY KIND UNDER THIS ASSIGNMENT. FOR THE PURPOSES OF THIS ASSIGNMENT EACH PARTY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT AND WARRANTIES ARISING FROM, COURSE OF DEALING OR USAGE OF TRADE.




