ARTICLES OF AMENDMENT
OF ARTICLES OF INCORPORATION
OF
HOLLAND USA, INC.

I, the undersigned, a Vice President of **Holland USA, Inc.**, a Minnesota corporation (the "Corporation"), do hereby certify that pursuant to that certain Plan of Merger with respect to the Corporation and its sole shareholder, Banyan Incentives, Inc. (the "Parent"), effective as of February 1, 2011 and adopted pursuant to Minnesota Statutes Section 302A.621 by the unanimous written consent of all the directors of the Parent (the "Plan"), the following amendments to the Corporation's Articles of Incorporation were adopted pursuant to Minnesota Statutes, Chapter 302A:

A. Article I of the Articles of Incorporation of this corporation shall be amended to read as follows:

B. That said amendment shall be effective immediately following the Effective Time (as defined in the Plan) of the merger of the Parent into the Corporation.
