## ASSIGNMENT OF REGISTERED TRADEMARKS

This Assignment of Registered Trademarks (this "Assignment") is made and entered into as of January 1, 2016 (the "Effective Date"), by the selling entities listed on the signature page hereto (collectively, "Seller") for the benefit of SGS Accutest Inc., a Delaware corporation ("Purchaser"). ### RECITALS

WHEREAS, Seller is the owner of the trademarks now registered in the United States Patent and Trademark Office which are listed on Exhibit A attached hereto (the "Registered Trademarks").

WHEREAS, Purchaser and Seller have entered into that certain Asset Purchase Agreement, dated as of even date herewith (the "Purchase Agreement") pursuant to which Seller has agreed to assign the rights, title and interest in and to the Registered Trademarks listed on Exhibit A attached hereto and Purchaser has agreed to acquire the Registered Trademarks.

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, effective as of the Effective Date, the parties agree as follows:

1. Seller hereby constitutes and appoints Purchaser as Seller's true and lawful attorney in fact, with full power of substitution in Seller's name and stead, to take any and all steps, including proceedings at law, in equity or otherwise, to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest or perfect the aforesaid rights and causes of action more effectively in Purchaser or to protect the same or to enforce any claim or right of any kind with respect thereto. This includes, but is not limited to, any rights with respect to the Registered Trademarks that may have accrued in Seller's favor from the respective date of first use of any of the Registered Trademarks from the Effective Date of this Assignment. Seller hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

2. Seller hereby assigns to Purchaser, all right, title and interest in the United States in and to the Registered Trademarks together with the goodwill of the business symbolized by the Registered Trademarks and registrations thereof.
