
**WHEREAS**, the Grantee desires to release the marks listed in Exhibit A from the Confirmatory Grant.

**NOW THEREFORE**, to all who it may concern be it known that for and in consideration of the payment to the Grantee of the full amount of the indebtedness described in the Security Agreement, the Grantee hereby (a) releases and discharges all the security interests granted by the Confirmatory Grant, being the security interests granted in respect of the trademarks and all other Collateral, and (b) acknowledges, confirms and agrees that the Confirmatory Grant is discharged, released and terminated and of no further force or effect.
