RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of September 28, 2016, among ROCKET SOFTWARE, INC., a Delaware limited liability company (the "Borrower"), the subsidiaries of the Borrower listed on Schedule I hereto and CREDIT SUISSE AG, as administrative agent and collateral agent (in such capacity, the "Administrative Agent").

WHEREAS, the Borrower and the Administrative Agent entered into that certain Second Lien Credit Agreement dated as of February 8, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Borrower, the lenders from time to time party thereto (the "Lenders") and Credit Suisse AG, as Administrative Agent, pursuant to which agreement the Lenders agreed to extend credit to the Borrower subject to the terms and conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, and pursuant to that certain Second Lien Guarantee and Collateral Agreement dated as of February 8, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement") among the Grantors (as defined therein) and Credit Suisse AG, as Administrative Agent and that certain Second Lien Trademark Security Agreement dated as of February 8, 2012 (the "Trademark Security Agreement") among the Grantors and Credit Suisse AG, as Administrative Agent, the Grantors granted security interests in certain intellectual property owned by the Grantors, including, without limitation, the Trademarks listed on Schedule II attached hereto (as further defined in the Trademark Security Agreement, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office at Reel/Frame 4730/0201; and

WHEREAS, the Administrative Agent has agreed to terminate and release the entirety of its security interest in and to the Trademark Collateral;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby is acknowledged, the Administrative Agent hereby releases all of its security interest in the Trademark Collateral and cancels and terminates the Trademark Security Agreement, without representation, recourse or warranty whatsoever, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Trademark Collateral to the applicable Grantor.

The Administrative Agent shall, at Grantors' expense, take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Agreement.

The Administrative Agent hereby authorizes the Grantors or any of their authorized representatives to file this Agreement with the United States Trademark Office or any other applicable governmental office. The Administrative Agent hereby further authorizes and

requests that the Commissioner for Trademarks and any other applicable government officer record this Agreement.


This Agreement shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law or choice of law principles.
