ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers, conveys, sets over, and delivers unto Assignee and Assignee's successors and assigns forever: (i) all of Assignor's right, title, and interest in and to the Mark, together with the goodwill of the business connected with the use thereof and symbolized thereby; (ii) the right to apply for and obtain registration for the Mark and all rights of renewal and extensions thereof; (iii) all common-law rights related to the Mark; and (iv) the right to sue for all past, present, and future infringements, dilutions, and other violations of the Mark and to recover damages and other amounts related thereto. Assignor will cooperate and work with Assignee and will provide and execute any and all additional papers, documents, or instruments necessary to complete the Assignment herein and vest title to and ownership of the Mark in Assignee.

This Assignment of Trademarks is being executed pursuant to the terms of the Stipulation of Settlement, dated October 3, 2016, by and between David Blackstone, John B. Economou, Thomas Ballis, Peter Giallis, Brooklyn Popcorn Company LLC, and Online Popcorn Corporation.
