## **RELEASE OF TRADEMARK SECURITY INTEREST**

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of October 11, 2016, is made by Ally Commercial Finance LLC, as lender (“Grantee”), in favor of the Grantors party to the Intellectual Property Security Agreement (as defined below).


**WHEREAS**, pursuant to the terms and conditions of (i) that certain Intellectual Property Security Agreement, dated as of July 11, 2011 and recorded with the United States Patent and Trademark Office on January 5, 2012 at Reel 4692 Frame 0558 (the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein shall have the meanings given to them in the Trademark Security Agreement), made by the Grantors in favor of the Grantee, and (ii) the Third Amended and Restated Loan and Security Agreement (as defined in the Trademark Security Agreement; hereinafter, the “Security Agreement”), Grantors pledged and assigned to Grantee, a security interest in all right, title or interest in or to any and all Trademarks then owned or at any time thereafter acquired by such Grantors or in which such Grantors then had or at any time in the future may acquire any right, title or interest, including those listed on Schedule I (collectively, the “Trademark Collateral”).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (i) terminates the Trademark Security Agreement, and (ii) releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests in the Grantors’ Trademark Collateral granted pursuant to the Trademark Security Agreement and/or the Security Agreement, including the Trademark Collateral listed on Schedule 1 hereto.
