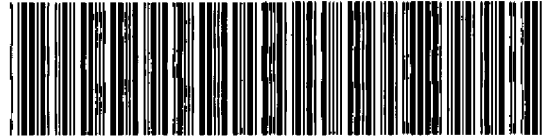

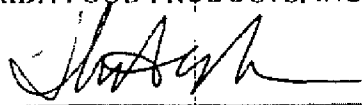

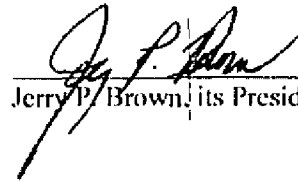

The name of the limited liability company is: Florida Food Products, LLC.

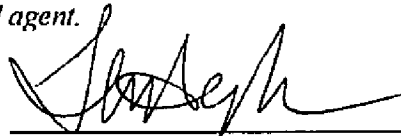

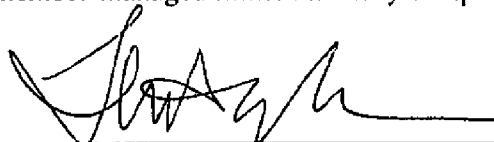
