TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (“this Agreement”) is entered into by and between Assignor, Cast Recovery Services of Santa Monica, Inc., a California corporation (“Assignor”) and Assignee, Cast Holdings LLC, a Delaware Limited Liability Company (“Assignee”), and is made with respect to the following recitals and is made effective October ¹², 2016.

WHEREAS, Assignor has received a registration for the mark CAST (in class 044) (the “Assignor Trademark”), namely US Trademark Registration No. 5,049,386 (the “Assignor Registration”).

WHEREAS, Assignee is the successor of the ongoing and existing business or portion thereof of Assignor related to the Assignor Trademark.

In consideration of the premises, mutual covenants and agreements contained in this Agreement, the parties agree as follows:

Terms and Conditions

1. Assignor hereby sells, assigns and transfers to Assignee all of Assignor’s right, title and interest in and to the Assignor Trademark in any typeface, stylization, colors, and/or capitalization, and any US state, federal or foreign applications and registrations of the foregoing, including the Assignor Registration, including the goodwill associated therewith (altogether, the “Assignor Trademark Rights”). Assignor further agrees to execute any documents reasonably necessary to effect the transfer of the Assignor Trademark Rights to Assignee.
2. Assignor acknowledges receipt of adequate consideration.
3. Assignor represents that Assignor has used or is the beneficiary of the use by others of the Assignor Trademark as a trademark and has thereby obtained goodwill in the mark.
4. The validity, construction, and performance of this Agreement shall be governed by the laws of the State of California without regard to principles of conflicts of law.
5. The parties hereto are separate and independent legal entities. Nothing herein contained will be construed or deemed hereby to create a principal/agent relationship between the parties nor any form of partnership or joint venture.
6. This Agreement may be executed in two or more counterparts each of which shall be deemed an original but both of which together shall constitute one and the same instrument.
