**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of October 14, 2016, from CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Collateral Agent (the "Collateral Agent") to ALARM SECURITY GROUP LLC (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Collateral Agreement (Second Lien), dated as of July 1, 2015, in favor of the Collateral Agent (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Collateral Agreement"), Grantor granted a continuing security interest (the "Security Interest") to the Collateral Agent in all Intellectual Property of the Grantor, including all of those items listed on Schedule A hereto (the "Trademark Collateral");

WHEREAS, pursuant to the Grant of Security Interest (Second Lien) in Trademarks, dated as of July 1, 2015, in favor of the Collateral Agent (the "Trademark Security Agreement"), Grantor, by reference to the Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Collateral Agent in the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 10, 2015 at Reel 5578 and Frame 0271;


WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:


1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Collateral Agreement and the Trademark Security Agreement.
2. Release of Security Interest. The Collateral Agent hereby terminates, releases, cancels and discharges, without recourse, representation or warranty, all right, title and interest in, to and under the Trademark Collateral, including, without limitation, its Security Interest therein, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.
3. Termination. The Collateral Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.
4. Further Assurances. At Grantor's sole cost and expense, the Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably requested by the Grantor to effect the release of the Security Interest in the Trademark Collateral contemplated hereby.
