**TRADEMARK ASSIGNMENT**

Gallup agrees to execute and deliver all such further transfers, assignments, conveyances and assurances and take or cause to be taken such actions as may reasonably be requested for Healthways to obtain the full benefit of this Assignment.

This Trademark Assignment and all of the provisions hereof shall be binding upon and inure to the benefit of the parties and their respective successors and assigns. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Trademark Assignment shall be governed by and construed in all respects, including validity, interpretation and effect, in accordance with the laws of the State of Delaware without giving effect to the principles of conflicts of laws thereof.
