PreCash, Inc. (the "*Corporation*"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby file this Certificate of Amendment (this "*Amendment*") and certify that:

1. The name of the Corporation is PreCash, Inc. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on September 24, 2002. Amended and Restated Certificates of Incorporation were filed with the Secretary of State of the State of Delaware on December 17, 2002, October 26, 2005, August 27, 2015 and August 27, 2015 (as so amended, the "*Certificate of Incorporation*").

2. This Amendment was duly adopted in accordance with Section 242 of the General Corporation Law of the State of Delaware.

3. The first section of the Certificate of Incorporation is hereby amended to read as follows:

"**FIRST:** The name of the corporation is Noventis, Inc. (the "*Corporation*")."


4. Article I of the Certificate of Incorporation is hereby amended to read as follows:

"The name of the Corporation is Noventis, Inc."

5. This Amendment shall become effective on August 1, 2016 in accordance with the provisions of Section 103(d) of the General Corporation Law of the State of Delaware.
