6. A written operating agreement has been entered into among the persons who will be members of the Converted Entity pursuant to the election herein. Such operating agreement will be effective immediately upon the effectiveness of such election. Such operating agreement provides for the manner and basis of the conversion of the ownership interests in the Converting Entity into interests as members in the Converted Entity.

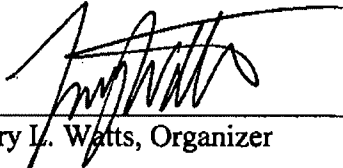
