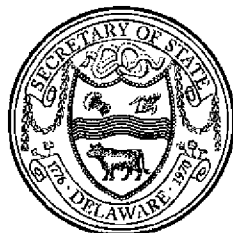

Pursuant to Section 264 of the Delaware General Corporation Law, as amended (the "Law"), the undersigned does hereby certify as of this 20th day of December, 2013, that:

SEVENTH: The merger shall become effective at 11:00 PM ET on December 31, 2013.


